KUALITI ALAM AND PETRONAS SIGNS AGREEMENTS FOR SCHEDULED WASTE SERVICES IN PENGERANG INTEGRATED COMPLEX.

KUALA LUMPUR, January 16, 2017 – Kualiti Alam Sdn Bhd (KA) and PETRONAS today signed the agreements for Collection, Transportation, Treatment and Disposal (CTTD), of Scheduled Waste Services for Pengerang Integrated Complex (PIC), in Pengerang, Johor.

The 5+5 year CCTD was signed between KA and PETRONAS' subsidiaries, PRPC Refinery & Cracker Sdn Bhd (PRPC RC), PRPC Polymers Sdn Bhd (PRPC Polymers) and PRPC Utilities & Facilities Sdn Bhd (PRPC UF).

The CCTD contracts to KA marks a new landmark in Hazardous Waste Management in Malaysia complementing PETRONAS' PIC development to add value and capitalise on the growing need for premium differentiated petrochemical and commodity products in Asia, establishing new engines of growth and pushing the nation into a new frontier of technology and economic development under the Economic Transformation Programme (ETP). It also demonstrates KA's continued commitment to be the Trusted Partner in Environmental Solutions.

These contracts signify PETRONAS' seriousness to provide the general public as well as surroundings of the PIC development with its care for the environment by early arrangement for the treatment and disposal of scheduled waste that will comply with Malaysian Law and international industry practices. The contracts also provided opportunities for local participation in the PIC development.

In 2014, Khazanah Nasional Berhad, in line with its support towards the country's sustainable agenda, acquired 100% of UEM Environment Sdn Bhd ("UEME"), the environmental holding company from the UEM Group. The holding company has since been re-branded as CENVIRO GROUP, with a clear mission of being **Champions in Preserving the Environment**.

In line with this, Khazanah has fully supported Cenviro's satellite facilities expansion plans, the first satellite being in the state of Johor via a newly incorporated 100% subsidiary, Cenviro Johor Sdn Bhd. Earlier in 2016; Cenviro Johor signed a long-term lease agreement with a state owned entity, Perbadanan Islam Johor or PIJ. This land is located within 14 km from the PIC. Cenviro Johor will house the new state of the art facilities that will provide Scheduled Waste management services to the PIC as well as to other parts of Johor. Its close proximity to the waste generators will enable services to be undertaken not only in a more efficient and effective manner, but also at significantly lower risk.

Cenviro Johor has started its initial investment on the lease land and has already designed an incinerator facility that will meet the technical requirements of our waste generators, and is targeted to be commissioned by January 2019. The land, which is about 40 acres in size, will enable Cenviro Johor to provide other facilities, such as recycling and recovery services related to waste from the various downstream activities of the oil and gas industry.

Cenviro Group expects to invest more than RM 150 million within the next few years in line with PIC's future development.
